Material Information	Upon review of the performance of subsidiary training companies and centers in the State of Kuwait, the United Arab Emirates, and Qatar, and review of the report of the CEO and the financial statements, and discussing potential options to address the matter, the Board of Directors decided the following: • Approving the closure and dissolution of the training centers and training companies in the State of Kuwait, the United Arab Emirates and Qatar, and the associated measures and financial impact. • Approving to contact the other partners in training companies in Qatar to discuss the closure and dissolution of the training centers and the training companies and their liquidation in accordance with the laws and regulations in force. Given that the ownership of Humansoft Holding Company in Qatar training companies is only 40% of the capital of each of these companies.
